Role Function and Purpose:	The Electrical Engineering Manager Delegate is responsible for acting on behalf of the Electrical Engineering Manager and has the same responsibilities as the Electrical Engineering Manager.
Obligations and Responsibilities	
Responsibilities:	The Electrical Engineering Manager Delegate shall act on behalf of the Electrical Engineering Manager, and is required to: - Accept the roles, responsibilities and obligations delegated to the position under the SHMS. - Maintain a sound understanding of the legislative and corporate SHMS requirements as they apply to the role of Electrical Engineering Manager. - Provide, where required, for adequacy and compliance at the mine with electrical requirements of: Coal Mining Safety and Health Act and Regulations, Electrical Safety Act and Regulations, and AS3000. - In relation to Coal Mining Safety and Health Act and Regulations, specifically: - Control and manage the design, installation and maintenance of electrical installations as specified in CMS&H Reg s18; s23; - Provide support to the Site Senior Executive in giving notice of proposed introduction of electricity as required by CMS&H Reg s19; - Verify through records, that persons carrying out repairing, overhauling and maintaining electrical equipment have the required competencies and authorisations. This includes but is not limited to requirements of CMS&H Reg s20; - Provide support in development and maintenance of Standard Operating Procedures as required by CMS&H Regulations, including: s21; s22; s38; s78; s112; s135; - Provide for full current isolators for equipment driven by electricity at the mine as required by CMS&H Reg s24;



	○ Provide and maintain standard for control circuits at the mine as required by CMS&H Reg s25; s23; s26; s27; and electrical protection s28; s29; s30; s31; s113; s114; ○ Provide for up-to-date drawings and plans of mine's electrical installations and communication systems as required by CMS&H Reg s32; s33; ○ Maintain records about mine's electrical activities, equipment and installations are kept at the mine as required by CMS&H Reg s34; • Assist the Site Senior Executive in maintaining appointments for electrical competent persons at the mine. • Routinely review relevant SHMS Action Plans to verify that appropriate corrective and preventive actions are planned and followed through to completion. • Provide systems and resources so that electrical statutory requirements and inspections are identified, scheduled and carried out across the site. • Review and audit electrical work procedures and practices in consultation with relevant operational personnel. • Review and provide support developing engineering specifications for use in scopes of work for any new installations, upgrades or overhauls carried out at site. • Issuing up to date specifications for new electrical installations, upgrades and overhauls. • Coordinate the maintenance of all remote electrical installations across site. • Manage installed automatic fire detection/protection systems across site. • Establish and maintain engineering libraries, drawing and software registers for all areas of site. • Provide Electrical Engineering expertise to areas of the site on an as required basis. • Manage phone and communications services in conjunction with service providers. • Develop and maintain standards for: ○ Equipment Certification Documentation; ○ PLC Programming; ○ Electrical Equipment Technical Specifications; ○ Specification for the Design and Installation of Electrical Equipment; ○ High Voltage Switching and Access Procedures; ○ Modifications to Electrical Control Systems; ○ Setting of Electrical Protection relays; ○ Design, Inspecting, Testing and Maintaining of Electrical Equipment and Earthing; ○ Design, Inspecting, Testing and Maintaining of Gas Monitoring Equipment; ○ Electrical Protection Relay Coordination; ○ Installation of accessible full current isolators; ○ Inspecting, Testing and Maintaining of Earth Leakage and Earth Continuity protection systems; ○ Updating and Maintenance of Electrical Control System, PLC and Reticulation System drawings; ○ Maintenance of Records and Documentation re: Electrical Activities, Equipment, Commissioning, Equipment Suitability and Installations; ○ Live Testing; ○ Installation and use of Fibre Optics; • Backup power supplies.
